On motion, upon unanimous call of the roll, the Board entered into executive session at 9:53 a.m. to discuss acquisition of property pursuant to Ohio Revised Code Section 121.22 (G)(2) and exited at 10:20 a.m.

Chris Brausch, Sanitary Engineer, was present along with Patty Solinski, Business Manager, to present a PowerPoint presentation and discussion relative to a proposed Water and Sanitary Sewer rate increase for 2012.

The Board reviewed the information presented and upon discussion, requested Mr. Brausch to schedule additional time of the agenda and bring information relative to future anticipated construction projects.

Mike Yetter, Zoning Supervisor, was present for the site plan review application of Collett Propane in Turtlecreek Township.

Mr. Yetter stated that Collett Propane would like to change the existing sign face at their property to include a LED display for better advertisement. He then reviewed the comments and recommendations received from various departments and officials and stated his recommendation to approve the site plan review subject to two conditions.

Ed Langley, KAP Signs, stated that the property owner desire to increase their business and this is the most economical way to do so. He stated that the sign it automatically programmed from the manufacture to dim based on the specific longitude and latitude timing. He stated that the sign begins dimming in the afternoon/evening and by be running at 10-20% brightness by midnight.

Rosemary Stowe, adjacent property owner, stated her concern relative to the LED light becoming a nuisance.

Mr. Langley stated that the client has the ability to turn the sign off during evening hours.

Commissioner South stated she would like to add an additional condition that states the hours when the sign should be turned off.

Upon further discussion, the Board resolved (Resolution #11-0550) to approve the site plan review application subject to three conditions including the additional condition #3 stating the sign must be turned off from 11:01 a.m. until 6:00 a.m.

Mike Yetter, Zoning Supervisor, was present along with Jerry Spurling, Chief Building Official, Stan Williams and Robert Ware, Regional Planning Commission, Bruce McGary, Prosecutor's Office, various members of the Rural Zoning Commission and interested residents for a work session to discuss the proposed Warren County Zoning Re-Write.
