Mrs. Mason presented a list of the applications including the amount requested as well as the match required by them or other sources and a list of CDBG grant funds received throughout the years. She informed the Board that the estimated available funds for allocation are \$712,500.

PUBLIC HEARING

REZONING APPLICATION INITIATED BY THE RURAL ZONING COMMISSION (BAKER, INC., OWNER OF RECORD) TO REZONE 1.46 ACRES IN HARLAN TOWNSHIP FROM SINGLE FAMILY RESIDENCE "RU" TO COMMUNITY COMMERCIAL BUSINESS "B2"

The public hearing to consider the rezoning application initiated by the Rural Zoning Commission to consider the rezoning of 1.46 acres in Harlan Township owned by Baker, Inc. from Single Family Residence "RU" to Community Commercial Business "B2" was convened this 4th day of February 2014, in the Commissioners' Meeting Room.

Mike Yetter, Zoning Supervisor, stated that this is an existing Certified gas station and was zoning B2 prior to the adoption of the text and map amendments in 2011. He informed the Board that this was an oversight and should have not been changed in the map amendments and needs corrected.

Mr. Yetter stated that the Regional Planning Commission and the Rural Zoning Commission recommended approval of this rezoning application.

Stan Williams, Regional Planning Commission, stated that this application was initiated at the recommendation of staff due to the error of the county and there were no fees paid by the property owner.
