WHEREAS, Chris Brausch, Warren County Sanitary Engineer is recommending to this Board that they award the bid for the base bid plus the add alternate item included in the bid document; and

WHEREAS, upon review of such bids by the Warren County Sanitary Engineer, Federal Contracts Corp was the apparent low bidder for the base bid generators but was not the low bidder when combining the base bid plus the add alternate bid for transfer switches; and

WHEREAS, the bid submitted by ITT Water and Wastewater USA was the low bidder when combining their base bid and their add alternate bid; and

NOW THEREFORE BE IT RESOLVED, upon recommendation of the Warren County Sanitary Engineer, that the bid be awarded to ITT Water & Wastewater USA, 700 Lakeview Drive, Monroe, Ohio, for a base bid price of \$135,500.00 plus an additional \$7,800.00 for transfer of switches, for a total bid price of \$143,300.00; and

#### INVITATION TO BIDDERS

Separate sealed bids for materials for Mobile Generators will be received by the Warren County Board of Commissioners at the Office of the Warren County Commissioners until 10:15 a.m., April 28, 2009, and then at said time publicly opened and read aloud in the Commissioners Meeting Room at 406 Justice Drive, Lebanon, Ohio 45036.

Bid documents and specifications may be obtained at the Office of Management and Budget, 406 Justice Drive, Lebanon, Ohio, (513) 695-1947. Questions regarding the technical specifications should be directed to Mike Carter with the Warren County Water and Sewer Department, (513) 683-5808.

A Bid guaranty, as required by the Ohio Revised Code, Section 153.54, shall accompany each proposal submitted, as follows:

1. A Certified check, cashiers check, or letter of credit equal to five (5) percent of the bid. A letter of credit may only be revocable by the Owner. Upon entering into a contract with the Owner, the contractor must then file a performance bond for the amount of the contract and the bid guaranty will then be returned to the successful and unsuccessful bidders upon contract execution.

#### OR

A form of bid guaranty bond (attached) for the full amount of the bid. A bond is retained for the successful bidder, but returned to unsuccessful bidders after the contract is executed. Attention of bidders is called to all of the requirements contained in the bid packet.

No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof.

All bids shall be properly signed by an authorized representative of the bidder.

All bids shall be sealed and plainly marked "Bid Opening – Mobile Generators, April 28, 2009 at 10:15 a.m."

Warren County reserves the right to reject any or all bids submitted, to waive any irregularities in bids, and enter into a contract with the Bidder who in Warren County's consideration offered the lowest and best bid.
