FOR THE PROFESSIONAL HEALTH CARE AND BEHAVIORAL HEALTH CARE SERVICES FOR THE WARREN COUNTY JAIL AND THE WARREN COUNTY JUVENILE JUSTICE FACILITY AND THE ADDENDUM FOR THE ANTICIPATION OF THE PLANNED INCREASE AT THE WARREN COUNTY JAIL

WHEREAS, per resolution #10-0853, adopted June 22, 2010, this Board did approve a "Notice of Intent" to award bid for professional health care and behavioral health care services for the Warren County Jail and the Warren County Juvenile Justice Facility to Premier Health Care Services, Inc., and the results are on file in the Commissioners Office; and

WHEREAS, all documentation including, performance bonds, insurance certificates, etc., have been submitted by the contractor; and

NOW THEREFORE BE IT RESOLVED, to enter into contract with Premier Health Care Services, Inc., 332 Congress Park Drive, Dayton, Ohio, for the total amount of \$468,634.00 (Current) and \$579,500.00 (After Double Bunking Project Completed) a year for the Warren County Jail and \$76,250.00 a year for the Warren County Juvenile Justice Facility; as attached hereto and made a part hereof.

BE IT FURTHER RESOLVED, that this contract shall remain in full force and effect for a term of three (3) years beginning on July 1, 2010 and ending on June 30, 2013.
