On June 28, 2019 dispatchers April Kennard, Jennifer Key, Ashlee Rector, Rob Plummer and Supervisor Tonya Cornett overheard a robbery at gunpoint occur at a bank in an adjoining county. Those listening to the broadcast knew the bank was in close proximity to our county so the supervisor, Tonya Cornett, created a call to notify our northern county law units. Police Dispatcher Kennard, dispatched the call to the law agencies closest to the incident. Dispatcher Kennard, advised that the bank had just been robbed at gun point by a black male wearing a wig. Fortunately, the bank had thrown a GPS unit in with the money and dispatch was able to track the suspect in his vehicle as he proceeded south on Interstate 75. Dispatcher Key, Rector and Plummer began making notifications to other agencies in the path of the suspect. Sergeant Turpin with Springboro Police Department was on the interstate and got behind what he believed to be the suspect vehicle. Sergeant Turpin also noticed another vehicle from behind that would not pass him. As he followed the suspect vehicle, he noticed the other vehicle behind him abruptly get over three lanes and head to exit onto State Route 122. This movement was confirmed by dispatch as to what they were tracking on the GPS.

Deputy Falco was able to locate the vehicle which had exited onto SR 122 and eventually caught up to it in the area of Towne Boulevard and Hendrickson Road. The driver pulled over without fleeing and was taken into custody. West Carrollton Police had also been in the area and were on scene with Deputy Falco and Sergeant Turpin within minutes of the apprehension. West Carrollton seized the vehicle and placed the driver under arrest for robbery. If it were not for the quick actions and dedication of all dispatchers involved the suspect may not have been taken into custody.

Dog Warden In-Service Training

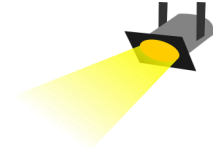

LEADS Audit & Hit Confirmations

LEADS Audit 2021

On Wednesday September 8th, 2021, LEADS conducted our 2021 LEADS audit. During our audit they checked warrants, protection orders, vehicles and missing person files along with other administrative paperwork and training files from the past 3 years.

I am very happy to say that we passed our audit. Thank you to all the dispatchers, supervisors and admin personnel for another successful LEADS audit. We could not have accomplished this without all your hard work!

Hit Confirmations- Confirming Warrants

It often happens when a unit is out with a subject and when the dispatcher runs the subject through LEADS/NCIC they have multiple warrants within the pick-up radius, and out of several different jurisdictions. The unit will ask the dispatcher to confirm the warrant(s) through one of the agencies that has an active warrant.

Per LEADS rules, every warrant (that is within the pick-up radius) must be confirmed. We cannot pick and choose which warrant we want to confirm. Also, If the warrant is **not** within the pick-up radius, we cannot send a hit confirmation.

We can make pick-up arrangements with whichever agency the unit wants to meet with. The other agencies will be notified either via phone or within the hit confirmation request, that the subject has multiple warrants and will be taken to whatever agency is decided on by the officer. This gives notification that the subject has been picked up.

Once the subject has fulfilled their obligation of charges with that initial agency, that agency will then let the other agencies with outstanding warrants know that the subject can be released into their custody.
