
In the Limelight: ECO Chris Carr

Did You Know?

EMD, EFD and EPD Recertification Due in February and March 2018

For the first group that was trained in EMD/EFD/EPD, recertification will be necessary in February and March. EMD recertification applications can be accepted as early as six months before the expiration date and as late as 90-days after. The process is:

1. Submit verification of 24 hours of CDE during the 2-year recertification period, with each credit based on an hour of participation.
2. Submit a copy of a current, valid CPR card.
3. Successfully complete the Academy's "open protocol" 50 question correspondence recertification exam with a score of at least 80%.
4. The completed application package can then be forwarded to the main business office so that it can be submitted with the proper fee.

Reminder to Mark Disabled Vehicles that Have Already Been Checked

Just a reminder to mark all disabled vehicles with yellow caution tape where it can be easily seen by a passerby after the vehicle has been checked by an officer. Dispatch will ask callers who are reporting a disabled vehicle or possible accident off the roadway if they can see any yellow tape in addition to a vehicle description so that we can avoid sending multiple officers to the same vehicle.



In The Spotlight

Call of the Month

On November 23rd shortly before 11:00 PM, the Communications Center received a call from the Ford vehicle Collision Warning System advising of a frontal collision with airbag deployment. When Calltaker Andy Jackson finally got the driver to talk to him, he said that he thought he'd hit a deer or some other kind of animal but before the officers arrived on the scene the driver left.

In the meantime, dispatch received several other 911 calls about a body that was laying by the side of the road in that same area. At that point, everyone in dispatch began working to assist those units working on the scene and to gather as much information about the driver of the vehicle as possible. Katrina Kouts was on the Police Primary 1 channel and was busy with the traffic from units responding to the crash; Doug Short was on Fire radio and had Clearcreek Twp FD responding to the same scene.



Ron Kronenberger, crew supervisor, began by calling Ford Sync to try and obtain information on the vehicle owner; Samantha Hall, on Police Primary 2, and Tonya Cornett, on Inquiry, started searching through LEADS for the subjects name, address or license number. Trainer Tramel Waddell with the assistance of trainees Sarah Oliver and Hannah Banks answered all other incoming calls. Great teamwork was displayed as every member of the crew worked diligently behind-the-scenes to provide the units on the scene with all the information that was available.

Units on the scene working this tragic crash were from Clearcreek Township PD, WCSO, OSP Post 83, and Clearcreek FD. Great job, everyone!

Warren County EMA Collaborates with Hamilton, Butler and Clermont Counties to Provide the Second Annual Regional Safety Summit

For the past year, Warren County EMA has collaborated with neighboring counties to provide this second annual Regional Safety Summit which brought together first responders, business owners, and volunteers to learn about initiatives, best practices for emergency and disaster response. The 85 participants were able to choose from a multitude of breakout sessions which included such topics as:

- National Weather Service Damage Assessment Process
- Unmanned aerial Vehicle Systems for Emergency Responders
- Business Continuity
- Pipeline Safety and Awareness
- Use of Social Media in Disasters
- Compassion Fatigue

The Summit concluded with a panel discussion on Hurricanes Harvey and Irma which included representatives from Ohio Task Force One, Kentucky-1 DMAT, and Butler County Incident Management Team, who were all deployed to assist with hurricane relief efforts.


