### **NCIC Warrants**

LEADS has encouraged agencies to enter serious offense warrants into NCIC regardless of the original pick-up radius. The reasoning is for officer and public safety purposes. Entering into NCIC also makes warrants available to NCIS Examiners for firearm transfer and firearm purchase decisions.

When you receive a hot hit from NCIC, the EXL (extradition) field is where you will see the change. For non nationwide pick-up & non felony warrants, the EXL code: 4 must be used. For non nationwide pick-up & felony warrants, the EXL code: D is used. If extradition has not been set the EXL code: 6 (NON FELONY) or F (Felony) will be used to indicate PENDING EXTRADITION DETERMINATION. You must then look at the MIS field. In the MIS field, the entering agency will provide extradition for the warrant. It may still be an adjacent pick-up only. Examples:

### Non Felony Warrants

MKE/WANTED PERSON

EXL/4 – NO EXTRADITION – IN-STATE PICK UP ONLY. SEE MIS FIELD FOR LIMITS

MIS/PICK UP IN SURROUNDING COUNTIES ONLY

### **Felony Warrants**

MKE/WANTED PERSON

EXL/D – NO EXTRADITION – IN-STATE PICK UP ONLY. SEE MIS FIELD FOR LIMITS

MIS/OHIO PICK UP ONLY

There are no restrictions on entering warrants into NCIC as long as they meet LEADS requirements. The only requirement for agencies that enter warrants into NCIC that are not nationwide pick up are the correct EXL field and the pick up noted in MIS field.

The scenario was a chemical exposure with multiple patients and objectives focused on jail procedures for chemical/medical incidents, internal and external communications, resource coordination, and incident recovery operations. Participants were engaged and contributed in deep discussions, culminating in improved processes for the jail and its responders.


Week 1:Sept 1-7
