DISCUSSIONS

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.
Dr. Sehi, Sinclair Community College, was present to receive a check from Warren County to provide scholarships to Warren County students attending the Courseview Campus.
Chris Brausch, Sanitary Engineer, was present along with Jeff England, developer within Hamilton Township, to discuss his request to delay the payment of water and sanitary sewer tap-in fees until such time that he is ready to connect his model home to the utilities.
Mr. England stated that in the economy of today, he cannot afford to pay the over \$17,000 in "up front" fees for the construction on his lot in Hamilton Township. He stated that with the new impact fee being collected by Hamilton Township that was not anticipated when he purchased these lots many years age, in connection with the down-turn of the economy, it makes it highly difficult to begin new construction when all fees are required to be paid prior to the issuance of a building permit.
Upon discussion, the Board agreed to authorize the building permit to be issued prior to tap-in fees being paid. They stated that all fees must be paid prior to a water meter being installed and put Mr. England on notice that whatever the fees are at the time he connects to the services will be the fees that will be due.
Commissioner Young requested the Board begin the process of expansion of the Warren County Common Pleas Court Building. He stated that the economy is beginning to pick up and he feels it is now appropriate to begin moving forward with the project.
