## DISCUSSIONS

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Bob Ware, Regional Planning Commission, was present along with representatives from the Village of Morrow, Rails to Trails, Salem Township, Harlan Township, Washington Township and Clinton County Rails to Trails, to discuss the request for the submittal of a grant application for the purchase of the abandoned rail line currently owned by Clinton County Rails to Trails.

Mr. Ware stated that the project has been named Todds Fork Trail and consists of approximately 14 mile sections of track with approximately 12 miles owned by Clinton County Rails to Trails. He stated the desire to apply for grant funds in the amount of \$200,000 from the Federal Transportation Alternative Program. He stated the minimum match is 20% but they application with rank higher with a 25% match. The match funds are being requested from the Board of Commissioners.

Eric Oberg, Rails to Trails, explained that this portion of the trail is a significant loop that will be completed. He stated the economic benefit that will be gained from this opportunity and that the Ohio to Erie was a huge economic driver in the area. He stated that the property being acquired is owned by Clinton County Rails to Trails, a non-profit organization that's mission is to complete trails within Clinton County. He then stated that the grant will be used to purchase from them to reimburse their purchase from approximately ten years ago.

Commissioner South questioned what the proposed development cost would be.

Kurt Weber, Chief Deputy Engineer, presented the proposed cost from \$3.5 million to \$6.5 million depending on the development plan chosen.

Mike Erwin, Mayor of Morrow, stated the support of this project from the Village of Morrow stated that this trail would tie into the existing bike trail through Morrow. He stated that the property could be used by families, for utility access and for economic development as the Village is proposing the construction of an innovation center.

Heath Kilburn, Salem Township Trustee, stated that the township is in support of the grant application.

Robert Curran, Harlan Township Trustee, stated that Harlan Township supports the project with the clarification of ownership of the railway line.

Mr. Oberg stated that the grant application is \$200,000 which would include not only the purchase cost but any title work that would be required prior to closing on the property.

There was discussion relative to who would own the property once it is purchased. It was determined that the Board of Commissioners would be the property owner and it could be turned over to the Warren County Park Board for maintenance and day to day operation.

Bruce Saunders, Clinton County Rails to Trails, stated that the purchase was made by Clinton County because it was a solid piece with no interruption of ownership and they wanted to preserve it for future purposes. He also stated that no Warren County entity was either willing or

able to make the purchase at the time. Clinton County Rails to Trails intent was always to sell the property back to Warren County.

Commission Young stated that that, in his opinion, this is a completely justifiable use of government funds and stated his appreciation of Clinton County Rails to Trails for securing this piece of property on behalf of Warren County.

Commission South stated her concurrence with Commissioner Young and her feeling that \$50,000 is a sound investment.

Commissioner Ariss stated his opinion that the project is good for the entire county.

Upon discussion the Board concurred to provide a 25% local match (\$50,000) if the grant application was selected for funding and resolved (Resolution #13-0536) to approve and authorize the submittal of an Application to OKI for allocation of Federal Transportation Alternatives Program Grant Funds from the Ohio Department of Transportation for purpose of acquiring the right-of-way for the proposed Todd's Fork Trail.

## PUBLIC HEARING

The public hearing to consider the rezoning application of initiated by the Rural Zoning Commission was convened this 9<sup>th</sup> day of April 2013, in the Commissioners Meeting Room.

Stephanie Austin, Warren County Zoning Department, reviewed the application and stated the Rural Zoning Commission recommendation to approve the rezoning application.

Stan Williams, Regional Planning Commission, stated that the property owners are in agreement with the recommendation. He then stated that Beth Callahan, Franklin Township Trustee, has stated that as long as the Interstate Highway Overlay "IHO" remains on the property included in the application, the Township is in support of the rezoning.

Richard Montgomery, property owner within the application, stated his agreement to the rezoning of his property and stated his desire to keep the City of Middletown and the City of Franklin from "gobbling up" this area.
