Chris Brausch, Sanitary Engineer, was present via conference telephone call to discuss the following 2020 waterline projects:

- City of Middletown Interconnect Project with the construction of 2,000 feet of water line, this project will provide an emergency connection with the City of Middletown. This is a relatively small project with an anticipated design contract of less than \$50,000.
  Consultant interviews are not recommended based on the limited scope and small engineering contract value.
- 2. Socialville Transmission Main Project This 24-inch water transmission main will allow the County to convey softened water to the Socialville area and must be completed by January 2026. This design will require easement acquisition and is anticipated to have an engineering contract value greater than \$500,000.
- 3. State Route 22&3 Water Line Relocation Project This small project will allow replacement of 3,500 feet of deteriorated water main near the Warren County Park District's Landen Park. This is a relatively small project with an anticipated design contract of less than \$50,000.
- 4. Hopkinsville Improvements Project Mr. Brausch recommended postponing the award of this project to allow coordination with the Warren County Engineer on their planned construction improvements to this area.

Mr. Brausch presented ranking sheets relative to the above projects and requested direction on how the Board desires to proceed. He then stated his recommendation to begin negotiations with the top ranked firm for each project.

There was discussion relative to the desire of the Board to interview the top three ranked projects for the Socialville Transmission Main Project as the value is approximately \$8 million with an engineering value greater the \$500,000.

The Board stated that due to the current environment, they desire to move forward with the recommendation of the evaluation committee on each project.
