Diabetic - The caller said her husband was having an episode of low blood sugar and maybe low blood pressure. Virginia did a good job selecting the most specific protocol and omitting the nothing to eat or drink PDI as well. Keep taking calls like this one!

Fall - The caller's husband had fallen in the kitchen and was unable to get up. April displayed excellent customer service with this caller by having a very kind demeanor, providing her with reassurance, and using her name during this call. Nice job!

Jordan Williams - 1270656 - CC 17:
Fall - The caller's husband fell and took the caller with him. Jordan enhanced the protocol and thought outside the box by asking if the caller also needed an ambulance. Jordan used calming techniques with this caller who was pretty worked up initially.

Virginia Brooks - 1278332 - CC 17:
Fall - Virginia used great customer service with the male caller. She offered to stay on the line with him when he had hesitation towards the end of the call.

Jennifer Key - 1268632 - CC 31: Unconscious - The caller's mother was unconscious. Jennifer expertly checked on the patient breathing. Jennifer moved easily through Pre-Arrival instructions and monitored the patient until help arrived.

Warren County Children Services Trunk or Treat




For those children who are in Children Service's custody, they get to have a safe and fun night of trick or treating. What a great event to be part of! We can't wait to participate again next year.

EMA Goes Back to School

Visiting Little Miami, Mason, Warren County Career Center & Wayne Local Schools



The EMA team visited multiple schools during the month of October to assist in various safety and preparedness efforts. Many school districts plan exercises, trainings, safety talks and demonstrations to prepare students and staff for disasters and emergencies. EMA is happy to assist the schools in these events!



Little Miami Safety Week

To kick off the month, EMA partnered with Little Miami Schools' Safety Week. Safety Week included presentations and demonstrations from EMA, fire, police and TRU.



EMA hosted a poster contest with the 2nd & 3rd grade classes at Little Miami Primary School. Mitigation Murphy, EMA's mascot, dropped off prizes and spent the day with the winning classes.




EMA also discussed tornado preparedness tips, having an emergency kit, and fire safety with all 2nd & 3rd grade classes, before heading to the Little Miami Early Childhood Center. EMA visited with Pre-K— 1st grade students to talk about when to call 911 and fire safety tips.

Mason Intermediate Exercise

In between safety presentations at Little Miami Schools, the EMA team took part in Mason Intermediate Schools' Reunification Exercise. The school practiced what to do in the event the school had to be evacuated, and the coordination of returning students to their guardians by utilizing their existing plans.



Exercises at Warren County Career Center

The EMA team has also been supporting the Warren County Career Center with their tabletop exercise and criminal justice class. The Career Center hosted a tabletop exercise to discuss the school's response to an active shooter, and then the process of reunification of students. Warren County Career Center staff utilized current plans and procedures to work through the exercise. This was a great discussion-based exercise to refresh long term staff on their roles, and allow an opportunity for newer staff members to ask questions about processes. Overall, better preparing the Career Center for emergencies that potentially could impact the school.


Along with taking part in the tabletop exercise, the EMA team partnered with the senior criminal justice class to teach an exercise development course. EMA has taught multiple sessions about the different aspects of exercise design, including an Introduction to HSEEP, how to develop exercise evaluation guides, creation of injects, and more! Once this exercise development course is complete, the criminal justice class will have developed a functional exercise for the school to utilize.



Wayne Local School District's Tabletop Exercise

To wrap up the month, EMA facilitated and took part in Wayne Local School District's tabletop exercise. The exercise scenario was about a bomb threat at the high school. Exercise participants discussed the actions they would take to maintain life safety, evacuate students and staff, reunify students with their guardians, and how information would be communicated among school staff, first responders, students, parents / guardians, and the media.

The team at Wayne Local School District hosted a lot of great discussion surrounding their processes of evacuation and reunification. With multiple staff members in new roles, different ideas were brought to the table to improve upon and increase effectiveness in existing procedures. The team at Wayne Local School District did a great job!

Yes, in all of these instances employees are “just doing their jobs,” or it’s not a big deal, but sometimes it’s nice to know that you’re appreciated!


Warren County Facilities





