Dave Gully, County Administrator, thanked the Department Heads present for their cooperation and support during the budget process as well as throughout the year for their conservative spending and also thanked them for being present to welcome Commissioner Tom Ariss at his first official meeting as County Commissioners.

The staff present in the audience introduced themselves to Commissioner Ariss and gave a brief statement explaining their department's function in County government.

Karen Whittamore and Gary Davis, Workforce One, were present to discuss a training request for a Franklin resident to complete his 2 year degree at an approximate cost of \$15,000.

Mr. Davis stated that he has now received an indication of the true cost of the schooling since he has received confirmation of receipt of a Pell Grant. He stated that the cost to the agency is more likely to be in the neighborhood of \$5000 but to err on the conservative side, he will stick with an estimated cost of \$10,000.

Commissioner Young stated he does not desire to know "people specific" information as this should not be a personal decision but rather a policy decision on behalf of the Board.

There was discussion relative to how individuals qualify to receive educational assistance and the average dollar amount spent per individual.

Mrs. Whittamore stated that the goal for the educational assistance is to get individuals off government assistance and/or unemployment compensation.

Upon further discussion, the Board approved the training request presented.

On motion, upon unanimous call of the roll, the Board entered into executive session at 9:40 a.m. to discuss personnel matters within Human Services pursuant to Ohio Revised Code Section 121.22 (G)(1) and exited at 11:37 a.m.

Commissioner Young and Commissioner South welcomed Commissioner Tom Ariss to his first official meeting as a Warren County Commissioner.
