DISCUSSIONS	

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Neil Tunison, County Engineer, was present to discuss the creation of a Transportation Improvement District (TID) pursuant to Ohio Revised Code Section 5540 within Warren County.

Mr. Tunison explained that a TID is authorized to finance, construct, maintain, repair, and operate street, highway and other transportation projects (including, but not limited to, air and rail relative to transportation projects) and in relation construct, reconstruct, improve, alter and repair roads, highways, public places, buildings and other infrastructure. He then stated the creating a TID in Warren County would allow eligibility to apply for funding within the State Transportation Bill. He then stated his desire to apply for funding upon creation of the TID.

Commissioner Young stated he is a fan of this concept. He stated a TID allows a unified infrastructure plan for the entire county and allows for a more efficient government.

Commissioner South requested clarification on the taxing authority of a TID.

Mr. Tunison stated he is not versed on exactly what they can do. He understands they have the ability to create assessment districts, levy assessments and levy a license tax fee.

Commissioner Young clarified that this would not be created in order to generate revenue.

Commissioner South stated she has no desire for the TID to exercise any taxing authority.

Dave Gully, County Administrator, stated that the Board of Commissioners create a TID and also has the authority to dissolve it.

Nick Nelson, County Auditor, stated he is curious how the finances would work. He stated his understanding that this is an independent district and the county treasury would not be involved, much like the Port Authority.

Mr. Tunison stated the financing matters are not worked out and would come at a later date. He then stated that the appointments on the Board of Trustees of the TID include an appointment by the President of the Ohio Senate and an appointment of the Ohio Speaker of the House.

Upon further discussion, the Board was informed of a meeting with local elected officials tomorrow relative to the TID and, depending on the discussion during that meeting, would consider adopting legislation to create the TID on Thursday.
