DISCUSSIONS

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Vicki Perry, Grants Administrator, and Margie Dunn, Balanced Housing Director, were present to discuss the application to receive \$250,000 for the Community Housing Improvement Program (CHIP) for FY 2011.

Mrs. Perry stated the application is for a 2 year program to provide down payment assistance and rehabilitation dollars, with the funds being secured by a second mortgage, to low and moderate income households. She stated that the average amount of assistance is \$20,000 with the maximum home price of \$150,000. She then stated the following basic qualifications:

1. income eligible

- 2. home buyer's classes and counseling
- 3. good credit history
- 4. good work history
- 5. obtain financing with a conservative debt ration (30/36%)
- 6. live or work in Warren County
- 7. house must be in Warren County

Mrs. Perry then stated that there are currently 100 loans outstanding with about \$1,000,000 rollover.
