Sheriff Sims was present and updated the Board on the various fundraising activities for Sgt. Brian Dulle's family.

The Board thanked Sheriff Sims and commended him on the tremendous job he did during the difficult time.

Sheriff Sims also updated the Board on the jail double-bunking project. He stated that the project is nearing completion and by next week, all prisoners being housed in the Butler County Jail will be back in Warren County.

On motion, upon unanimous call of the roll, the Board entered into executive session at 10:12 a.m. to discuss personnel matters within Children Services and the Sheriff's Office pursuant to Ohio Revised Code Section 121.22 (G)(1) and exited at 11:12 a.m.

Chris Brausch, Sanitary Engineer, was present for a work session and discussed the following matters:

- 1. Snook Road Sanitary Sewer Extension—The settlement in the lawsuit against Henderson and Bodwell from the 3 homeowners that were not serviced in the project due to a design flaw has been concluded. The Court has ordered the homes to be serviced at the expense of Henderson and Bodwell and in order to obtain sanitary sewer service, they must be served by South Lebanon. This will require a service agreement with the Village of South Lebanon.
- 2. Bill Hines, Director of Land Development for Caldwell Banker, called to question if the sanitary sewers in Deerfield Township would accommodate 250 single family units on the 70 acres Erbeck property. The Board stated it would not.
- 3. Ohio EPA-208 Facilities Planning Update—OKI Regional Council of Governments is working on an updated/revised map for Warren County.
- 4. Sump Pump and Downspout Inspections—Mr. Brausch stated his desire to begin inspecting downspouts and sump pumps upon transfer of service to ensure these are not infiltrating the wastewater treatment plant. The Board approved his request.

Upon motion the meeting was adjourned.
