Stan Williams, Regional Planning Commission Executive Director, was present to explain the Memorandum of Understanding (MOU) for Sustainable Communities Regional Grant Program Consortium that the Ohio Kentucky Indiana Regional Council of Governments has requested the Board approve.

Mr. Williams stated that this MOU does not commit Warren County to any financial commitment. He stated that this ensures our participation in the process which may include representation on a Board or Committee or providing data.

Upon further discussion, the Board resolved (Resolution #11-1070) to authorize President of the Board to enter into Memorandum of Understanding for the Sustainable Communities Regional Grant Program Consortium relative to OKI Regional Council of Governments.

Keir Holeman, Board of Elections Director, was present for discussion relative to the use of the Commissioner' Meeting Room (entire room) for the General Election this year and the Primary and General Election in 2012.

There was discussion relative to the need for the entire room for this year.

Mr. Holeman stated he would not need the entire room and that the back half of the room would be sufficient. He then stated that for 2012, it would require either the use of the entire room or if the Board could find an "off site" location that could accommodate the tremendous number of voters, he would be more that willing to consider rather than disrupting regular county business.

Upon further discussion, the Board stated their agreement to the use of the building and stated they would continue to look for other options for 2012 but if none are found, they stated their concurrence with the use of the Meeting Room.

VACATION OF A PORTION OF ROAD RIGHT OF WAY FOR UTICA ROAD AND GREENBRIER ROAD IN TURTLECREEK TOWNSHIP

The Board met this 2nd day of August 2011, in the Commissioners Meeting Room to consider the request of the Turtlecreek Township Trustees to vacation a portion of and certain right of way of Utica Road and Greenbrier Road in Turtlecreek Township.

Neil Tunison, County Engineer, presented a map of the area proposed to be vacated and explained that this is the previous right of way from prior to the road realignment. He then explained the color coded map showing the property that would revert to the adjacent property owners and recommendation the Board approve the request for vacation of said roadways.
