DISCUSSIONS
On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.
Sarah Hippensteel, Miami Conservancy District (MCD), was present along with Mike Ekberg for an update on the Aquifer Preservation Program.
Mr. Ekberg stated that the Aquifer Preservation Program monitors the water quality and quantity in the area. He stated that the goal is to protect the water resources in the area. He stated that MCD works with the local communities to protect their water resources through land use planning. He then commended Warren County for its Aquifer Protection Overlay through the zoning process.
Mr. Ekberg reviewed the various projects that Warren County and MCD have worked cooperatively on over the years.
Chris Brausch, Sanitary Engineer, stated that MCD has been great to work with and is always willing to help in any way possible.
Commissioner South questioned if MCD staff would be willing to review our current Aquifer Protection language and make recommendations where they feel any changes are needed.
Ms. Hippensteel stated that he would be pleased to review the language.
Upon discussion, the Board thanked them for the services they provide to Warren County.

Chris Brausch, Sanitary Engineer, was present to discuss the following matters:

- A Turtlecreek Union Road Resident recently inquired about charges relative to
 connection to the water line for his home. It was discovered that many years ago, a Water
 and Sewer employee failed to charge the non-participation fee to his next door neighbor.
 The homeowner is requesting to have the non-participation fee charge waived so he does
 not pay more than his next door neighbor paid for the water. Upon discussion, the Board
 declined his request.
- 2. Western Row Road Waterline Project—many years ago, a property owner granted an easement for the construction of a private waterline along his property in exchange for their portion of a non-participation fee being waived if and when they ever connected to the waterline. The property owners now desire to connect to the water system. Upon discussion, the Board agreed to the waiver of the non-participation fee.

Bruce McGary, Assistant Prosecutor, was present to discuss the resolution for a performance bond release and acceptance of streets within Columbia Woods Subdivision in Deerfield Township.

The Board received a letter from a property owner within the subdivision stating his objection to the bond release due to unresolved issues with the developer regarding a large ditch that was constructed in his backyard. He stated that several large pine trees were dug up and destroyed during the digging of a ditch resulting in a significant financial loss on his part. He also stated that there are remaining questions about the size and correct dimensions of the ditch as well as other financial issues regarding the care and maintenance of the re-growth of grass and overall care of the property.

Mr. McGary stated that the situation is that the homeowner filled in a drainage swale within an existing easement and planted trees. In order to meeting the approved drainage plan and have the subdivision performance bond released, the County Engineer required the drainage ditch be constructed as the approved plan shows. The developer entered upon the easement and removed the obstructions to then have the drainage improvements be in compliance with the approved plan. He then recommended the Board approve the release of the maintenance bond and accept the streets for public maintenance as there is no legal authority for the Board to delay this process due to all the conditions of the bond being complied with.

Upon further discussion, the Board approved the street and appurtenances bond release for G.T.R. Development, LLC for completion of improvements in Columbia Woods situated in Deerfield Township and approved Meadow Trail and Scenic Court in Columbia Woods for public maintenance by Deerfield Township.

PUBLIC HEARING CONSIDER THE ADOPTION OF THE WARREN COUNTY COMPREHENSIVE PLAN

The Board met this 15th day of November 2011, in the Commissioners Meeting Room, to consider the adoption of the Warren County Comprehensive Plan.

Stan Williams, Executive Director of the Regional Planning Commissioner (RPC), stated that the RPC Executive Committee held two public hearing regard the proposed plan and at the October 11, 2011, RPC Executive Committee Meeting, approved the adoption of the plan. He then stated the following major changes to the Comprehensive Plan from the 2007 approve plan:

- 1. The deletion of the SanMarGale Development
- 2. Franklin Township is changing from rural to suburban
- 3. The portion of Turtlecreek Township west of 741 is changing from rural to suburban
- 4. Updates relative to road right-of-way as approved in the Thoroughfare Plan

Mr. Williams then explained the Comprehensive Plan is a document that provides guidance for land use decisions, infrastructure improvements and housing location decisions. He stated the following elements are included in the plan:

- 1. Capital Improvement Report
- 2. 5 year Capital Improvement Plan Maintenance Effort
- 3. Economic Development Element
- 4. Housing Plan Element
- 5. Land Use Plan Element
- 6. Open Space Element
- 7. Maps
- 8. Transportation Element

Commissioner Young stated that this is a much needed document that Commissioner South was in favor of for years but it took him being elected as County Commissioner to get the second vote to proceed with the plan. He then stated his desire to share this plan with the surrounding governmental jurisdictions in order for them to be adequately informed on what we see the future of Warren County will be.

Commissioner South commended former and current staff on the years of work and planning that have gone into this plan and stated her excitement to be moving forward with not only the adoption of the Comprehensive Plan but the impending approval of the amendments to the Warren County Rural Zoning Code Text and Maps.

Robert Craig, South Lebanon Village Administrator and former Executive Director of the RPC, stated he is excited and supportive of the adoption of the Comprehensive Plan.

Upon further discussion, the Board approved the adoption of the Warren County Comprehensive Plan.
