Members of the Warren County Veterans Service Commission were present for a work session along with Neil Tunison, County Engineer, and Don Prince, Mason City Council, for a work session to discuss the desire to designate US RT 42 in Warren County as the "Warren County Veterans Memorial Highway".

There was discussion relative to the desire and authorization to make this designation.

All those present stated their desire to make this designation.

Neil Tunison, County Engineer, stated that the County has the authority to make the designation within the unincorporated areas but the municipalities would need to approve it within their jurisdictions. He also stated that ODOT approval would be required prior to erecting any signs.

Mr. Tunison then stated that if they have the State Legislation make the designation, all of US RT 42 in the State of Ohio could be designated "Veterans Memorial Highway".

Mr. Prince stated that Rep. Beck has drafted legislation to begin the process and also stated that the City of Mason has adopted legislation to make the designation within their jurisdiction.

The Veterans Commission stated their desire to fund the project.

Mr. Prince stated that we now have funding and the legal authority and discussion ensured relative to how this project should proceed.

There was discussion relative to what the signs should look like.

Commissioner Young suggested name the highway after the Congressional Medal of Honor winners from Warren County and also stated that this could be used as a model throughout the entire State of Ohio.

It was determined that the Board of Commissioners will contact each local government requesting a resolution or ordinance to make the designation. Mr. Tunison stated he will contact ODOT to begin the permit process for the signs and the Veterans Commission will contact each VFW and American Legion to get their support of the project.

Upon further discussion, the Board determined to continue this discussion to April 5, 2012, at 4:00 p.m.

On motion, upon unanimous call of the roll, the Board entered into executive session at 4:40 p.m. to discuss acquisition of property pursuant to Ohio Revised Code Section 121.22 (G)(2) and matters required to be kept confidential per federal or state law pursuant to Ohio Revised Code Section 121.22 (G)(5) and exited at 5:20 p.m.
