## DISCUSSIONS

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Stan Williams, Regional Planning Commission, was present along Neil Tunison, County Engineer, and Kurt Weber, Chief Deputy Engineer, for a work session to discuss the application for Federal Transportation Alternatives Program Grant Funds from the Ohio Department of Transportation for purpose of Acquiring the Right-of-Way for the proposed Todd's Fork Trail.

Mr. Williams explained that the State of Ohio will not fund this project due to Warren County not being a non-urbanized area. He explained that in order to receive funding through OKI Regional Council of Governments, the project must be State of Ohio funding eligible.

Mr. Tunison stated that the project could submit for funding in the future but would be higher ranked if the County had the money for construction. He then suggested that the project could be divided into segments as follows:

Engineering and right-of-way acquisition	\$465,000/\$518,000
Phase 1	\$2,511,280
Phase 2	\$1,837,100
Phase 3	\$1,508,700

Upon discussion, the Board resolved (Resolution #13-0660) to rescind Resolution #13-0536 to approve and authorize the Submittal of an application to OKI for allocation of Federal Transportation Alternatives Program Grant Funds from the Ohio Department of Transportation for purpose of Acquiring the Right-of-Way for the proposed Todd's Fork Trail.

Upon further discussion, the Board was informed that Clinton County Rails to Trails purchased the right of way for \$58,000 and the Board suggested purchasing the property directly from them after all court action has been settled and ownership is established.

Upon motion the meeting was adjourned.
