DISCUSSIONS

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Gene Steiner and Rebecca Osborne, Warren County Agricultural Society, were present for a work session to discuss the proposed agreement with Kleingers Group relative to a Master Plan that the Agricultural Society desire to have performed.

Commissioner South stated that the scope of work within the proposed agreement is more of a "cost to identify and cure deficiencies" agreement than a design service agreement for a master plan.

Commissioner Young presented background information relative to the forward thinking of the Board of Commissioners relative to the need to continue the financial sustainability of the fairgrounds and provided his perspective of the following options available at the site with #1 and #5 not being a viable option in his opinion:

- 1. Close it and move the fair
- 2. Minor fix up
- 3. Upgrade current facilities
- 4. Add additional facilities to make a "people destination"
- 5. Make the facility a "show place"

Commissioner Young stated his desire to upgrade the current facilities and add additional uses to make this a "people destination". He then stated his concern with the Commissioners spending millions of dollars on the upgrades and the need for the County to be in charge of any new improvements not associated with the County Fair. He then stated the need for the Agricultural Society to be "on the same page" as the County Commissioners.

Mr. Steiner stated he has no problem with the County Commissioners being in control of future improvements not associated with the county fair.

There was discussion relative to the scope of work proposed within the agreement with Kleingers Group.

There was discussion relative to the need to revise the current lease between the Warren County Agricultural Society and the Warren County Commissioners.

Mr. Steiner stated that he did not see a problem with the Agricultural Society approving a revised lease to allow the Commissioners control over proposed improvement areas as long as the Agricultural Society has the ability to accommodate the fair and activities associated with the Agricultural Society.

Michael Shadoan, Facilities Management Director, stated that he desires revise the scope of work in the agreement with Kleingers Group to better define the services that the Agricultural Society needs them to perform. He then stated he will revise the agreement in conjunction with the Agricultural Society.

Upon further discussion, the Board requested Bruce McGary, Assistant Prosecutor, to begin revisions on the lease agreement between Warren County Commissioners and the Warren County Agricultural Society.

Upon motion the meeting was adjourned.
