DISCUSSIONS

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Donald "Gus" Edwards, Wayne Township Administrator, thanked the Board for the outreach meeting and the opportunity to discuss Wayne Township.

Pat Foley, Wayne Township Trustee, presented a copy of the Wayne Township Community Magazine which is collaboration between Wayne Township, Villages of Waynesville and Corwin, Wayne Local School District, and the Mary L. Cook Public Library.

Mr. Foley then discussed the new 17,000 square foot Fire House project, the re-write of the Wayne Township Zoning Code now in effect, their participation in Ohio Checkbook, and the award of \$42,000 for new road signage.

Mr. Foley then requested the Board's consideration in waiving the sewer tap-in fee for the firehouse project.

Chris Brausch, Sanitary Engineer, stated that the Board has typically waived those fees for political subdivisions.

The Board requested that Mr. Edwards provide a written request for the fee waiver.

Mr. Brausch provided an overview of the water and sanitary sewer services provided within Wayne Township.

Martin Russell, Deputy County Administrator, discussed economic development within the County, including enterprise zone and Community Reinvestment Area tax abatements which allow the townships to offer incentives for new businesses. He then updated the Township on the ability of the Warren County Port Authority to help with project funding.

Pat Dubbs, Wayne Local Schools Superintendent, thanked both the Township Trustees and the County Commissioners for their partnership and support of the schools.
