The Board met this 29th day of January 2019, to render a decision relative to the Vacation Petition of the Deerfield Township Trustees to vacate a portion of Pinnacle Lane in Deerfield Township.

Kurt Weber, Chief Deputy County Engineer, presented the resolution prepared by Bruce McGary, Assistant County Prosecutor, which vacates the portion of Pinnacle Lane and clarified in detail the reservation of easements to include the pavement remaining intact for access to the County's pumping station property. He clarified that this draft resolution does not include any requirement for the property owner to construct or maintain an access to Bethany Road or connect to the adjacent subdivision pedestrian path.

Upon further discussion, the Board resolved (Resolution #19-0142) to declare a portion of Pinnacle Lane (Township Road 2259) in Deerfield Township, Warren County, Ohio to be vacated.

On motion, upon unanimous call of the roll, the Board entered into executive session along with representatives from the Prosecutor's Office at 9:11 a.m. to discuss pending litigation relative to Children Services pursuant to Ohio Revised Code Section 121.22 (G)(3) and exited at 9:58 a.m.
