DISCUSSIONS

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Students from Lebanon High School Government Class were present to participate in Student Government Day.

ADMINISTRATIVE HEARING CONSIDER VARIANCE OF CONDITIONS REQUIRED FOR AN ACCESS PERMIT OF ARCHBISHOP DANIEL E. PILARCZYK OF CINCINNATI, TRUSTEE (ST. MARGARET OF YORK) IN DEERFIELD TOWNSHIP

The Board met this 19th day of March 2019, for the administrative hearing to consider the Request for Variance and Appeal of Conditions required for an Access Permit that had been filed on February 21, 2019 by the owner, Archbishop Daniel E. Pilarczyk of Cincinnati, Trustee, Agent for the Applicant, St. Margaret of York – Mike Ott, for access to Columbia Road for Parcel #16-20-401-0170 in Deerfield Township.

Tina Osborne, Clerk of Commissioners, stated that a notice had been published in <u>Today's Pulse</u> of <u>Lebanon and Mason</u> newspaper on March 3, 2019, advertising the date, time and purpose of the public hearing and that written notice had also been mailed to the Applicant and the Deerfield Township Board of Trustees on February 26, 2019. She then read into the record what documents were filed with the Clerk and that would be considered by the Board relating to the request for a variance of the Warren County Access Management Regulations.

Chief Deputy County Engineer, Kurt Weber, was sworn in and testified that the Applicant filed for a variance of the requirements in Section 401.8.2-c (Table 1) "Access Spacing Requirements" of the Warren County Access Management Regulations because an Access Permit had been denied by the County Engineer's Office due to proposed right-in/right-out limited access onto Columbia Road from the Church's parking lot being proposed at only 200 feet from the Church's main driveway to the north, and only 320 feet from the closest drive to the south, but the Section 401.8.2 (c) requires a minimum of 360 feet of access spacing. He presented an aerial map showing the location of the requested access along with the proposed traffic flow. He reviewed the Engineer's Report containing answers to general questions/facts and the Engineer's opinion relative to the factors to be considered when granting a variance. He then stated the Engineer's recommendation to approve the requested variance.

Craig Abercrombie, Abercrombie & Associates, engineer representing St. Margaret of York, was sworn-in along with Michael Ott, St. Margaret of York employee, and testified that the parking lot is to be reconfigured for safety and that access onto Columbia Road is a limited access allowing only right turns.

Mr. Ott testified that the requested access is necessary in order to eliminate backup onto Columbia Road during school drop off and pick up.

Commissioner Jones confirmed with the applicant's representative that the witnesses were given a reasonable opportunity to present their position, arguments and contentions, as well as examine witnesses, cross-examine witnesses, and present evidence in support of the variance.

Upon further discussion, the hearing was closed and the Board resolved (Resolution #19-0366) to approve the Variance of Conditions required for an Access Permit of Archbishop Daniel E. Pilarczyk of Cincinnati, Trustee (St. Margaret of York) in Deerfield Township.

Chris Brausch, Sanitary Engineer, was present along with staff for a work session discuss various future waterline presents.

Mr. Brausch presented the attached PowerPoint presentation discussing several waterlines needed over the next few years in order to ensure redundancy of services in the event of a waterline break or wellfield contamination.

The department proposed the following:

Construct a connection with the City of Middletown for backup water source for the North Treatment Plant at an approximate cost of \$250,000.

Caesar Creek Lake—Construct a waterline across SR 73 Bridge for redundancy of services for 300 Harveysburg residents, ODNR and USACE Facility in the event of a waterline break to the line within Caesar Creek Lake at an approximate cost of \$200,000.

Construct a transmission main from Richard A Renneker Water Treatment Plan to the Socialville Booster Pump Station in order to supply softened water to the Socialville customers at an approximate cost of \$8.7 million

State Route 22 & 3—Replace problematic cast iron water line constructed in 1960 in the area along Landen Park at an approximately cost of \$350,000

Hopkinsville Improvements—Replace cast iron main constructed in 1960 that is failing and undersized at an approximate cost of \$750,000

Columbia Road—Replace cast iron main constructed in 1971 that is failing and undersized at a cost of approximately \$1.2 million

Mr. Brausch requested approval to issue one request for qualifications (RFQ) for all of the proposed projects and allow selection from the various submittals for each project.

Commissioner Jones stated her concern with the RFQ being issued three years prior to proposed construction. She stated that a firm not in the position to be considered today may be the best firm in the future.

Commissioner Young stated his desire to identify the top priority project within the RFQ and not all at the same time.

There was discussion relative to the project timelines and the selection of firms.

Upon discussion, the Board authorized Mr. Brausch to continue working with the Prosecutor's Office on the RFQ and the concerns of the Board will be addressed when selecting the projects.

It was also determined that a Review Committee will make a recommendation on firm selection to the Board and that all project funding is within the capital improvement plan of the Water Department and no borrowing will be needed to complete the proposed projects.

On motion, upon unanimous call of the roll, the Board entered into executive session at 10:12 a.m. to discuss pending litigation with Children Services pursuant to Ohio Revised Code Section 121.22 (G)(3) and exited at 11:25 a.m.

Upon motion the meeting was adjourned.



SOCIALVILLE TRANSMISSION MAIN


SCOPE: 24-inch water line from the RAR Water Treatment Plant to the Socialville Booster Station.

COMPLETION: 2026






FIGURE 2 COLUMBIA RD

Water & Sewer Request

- Authorize the Water & Sewer Department to issue one Request for Qualifications (RFQ) for design services for the proposed projects.
- Work with the WC Prosecutor so that the RFQ can be used to select different engineering firms each project.
- The RFQ also be used to select any additional water line design projects that are approved by the BOCC in 2019 through 2022.
- Based on the RFQ submittals, the Water & Sewer
 Department recommend engineering firms for each
 project that are then approved by the BOCC.
