DISCUSSIONS

The Board met in special session for a work session to discuss the request of City Gate Church to utilize a portion of the property where the Warren County Water Warehouse is located on Monroe Road within the City of Lebanon for a fireworks display over the Memorial Day weekend.

Mrs. Zindel, County Administrator, stated that in follow-up to the discussion on May 19, 2020, she has been in contact with the City of Mason and received a copy of their agreement with Mason Schools relative to the fireworks displays they offer. She stated that Bruce McGary, Assistant Prosecutor, has made modifications to the agreement for Warren County's use. She stated that the agreement requires the church to provide insurance, a permit from the City of Lebanon, to clean up after, a professional fireworks company. She then stated that the Fire Department will be on premises for the show.

Chris Brausch, Sanitary Engineer, stated that the warehouse property is not active on weekends unless they receive a "call out". He then suggested the church conduct a site visit as the property in question is wet. He then stated that the gate around the property is locked and they will need to contact him if access is needed.

Blake Mason, City Gate Church, stated that the date of the event is Saturday, May 23rd, not Sunday, May 24th.

Jason Louis, Yokum Fireworks, LLC, stated they have surveyed the property and the event has been approved by the Lebanon Fire Chief. He also stated that it is the responsibility of their company to clean up after the event.

Commissioner Grossmann stated he is ready to approve the request.

Commissioner Jones questioned what all the agreement entails.


Bruce McGary, Assistant Prosecutor, reviewed the license agreement and confirmed the release of liability clause contained within the agreement.


