





#### **Dr. Joseph Warren Memorials**

#### A Proposal:

A group of Warren County residents known as "Friends of the 20 Mile House", in concert with the Warren County Historical Society and the Warren County Genealogical Society have proposed the design, funding, creation and maintenance of two physical memorials for Dr. Joseph Warren, the namesake of Warren County, Ohio. These memorials would be placed in prominent, highly visible locations on Warren County grounds and Warren County Historical Museum grounds.

#### Who?

The human timeline is littered with people who changed history in a substantial manner without the benefit of significant acclaim or lasting notoriety. Such is the case for Dr. Joseph Warren. By the time the Declaration of Independence was signed on July 4, 1776, Joseph Warren had been dead for thirteen months, his a martyr's death in the closing minutes at the Battle of Bunker Hill.

From 1760-1775, Massachusetts was the heart of colonial political agitation, social unrest and economic turmoil. It was here that a small cluster of traitors to the British Crown arose in spite of the fact that they had no military support and minimal financial resources. Of all the Massachusetts revolutionaries, Dr. Joseph Warren was the most diverse and omnipresent. His role as a physician gave him unique respect along all points of the political spectrum, but in particular his presence lent legitimacy to the early Whig movement. His clandestine maneuverings countered the British intelligence in place throughout Boston.

In recognition of Warren's ceaseless efforts and in spite of his lack of genuine military experience, the Massachusetts Provisional Congress, on the afternoon of June 14, 1765 appointed him the rank of Major General. When Dr. Warren learned on the morning of June 17<sup>th</sup>, that the British had landed in Charlestown, he quickly prepared himself and left from Cambridge to unite with the provincial forces. Despite the multitude of friends and colleagues who had reminded him of his irreplaceably plural leadership roles within their rebellion, Warren was resolute. He would not linger safely in the background. He knew that no one knew the topography of Charlestown better than he did. But he also knew he had no business defining the strategic conduct of the impending battle. He arrived at

the scene dressed in his Dr. Warren finery, a powdered wig, white satin waistcoat, and white breeches. He refused both General Israel Putnam and Colonel William Prescott's respectful offers to take command of the field, and chose instead to fall in with Prescott's men in the newly dug defensive trenches. He was armed with pistols, musket, sword, Bible and a vital sense of purpose.

In the forensic analysis of the day's events, soldiers spoke of the lift provided by the presence of Major General Joseph Warren within their trenches. They had successfully repelled two significant British advances throughout the day, but by the time a third advance was initiated the provincial forces had spent their limited ammunition. They were reduced to hand-to-hand conflict against superior numbers. It was while Dr. Warren was covering the retreat of his men toward the safety of the Boston Neck, when a single shot caught him beneath his left eye, an instantly fatal passage that crossed the mid-line of his brain and exited the occiput on the opposite side.

So strong was British resentment of Dr. Warren's influence among the "traitors" that his body was mutilated beyond recognition after his death, and disposed of in a common grave with his fellow fallen patriots. Joseph Warren did not live long enough to be an American. He died at age thirty-three, a traitor to King George III in his doggedly relentless pursuit of the liberties we still enjoy today.

#### Why?

Ohio's Warren County was defined and created in 1803, the same year Congress gave its final approval to the resolution establishing Ohio as the seventeenth state. As was the case for most of Ohio's earliest counties, Warren County was named as a tribute to one of the early heroes of the American Revolution, in this case, Dr. Joseph Warren.


Coming out of the Friends of the 20-Mile House cluster was a stated observation. There is an absence of opportunities or places within Ohio's Warren County for the citizenry or visitors to be introduced to Dr. Joseph Warren and his story of ingenuity, healing, and self-sacrifice. Furthermore, as stewards of this neglected history, the responsible thing is to establish readily available memorials introducing and honoring Dr. Joseph Warren and his sacrificial contributions to who and what we are today as Americans.

#### What?

Two different Dr. Joseph Warren Memorials are proposed.

1. An outdoor Memorial, at a prominent site, consisting of a statuary representation of Dr. Joseph Warren accompanied by a biographical plaque. Michael Coyan, Executive Director of the Warren County Historical Society, has initiated conversation with potential artists who could be considered for the commission of this statuary project. A bronze bust on a marble base should fall in the \$8,000-10,000 range, while a 4-ft full body sculpture should be \$12,000-18,000.

2. An indoor Memorial, at a prominent site, consisting of a portrait depicting Dr. Joseph Warren accompanied by a biographical plaque. One option for an appropriate portrait would be the effort of John Singleton Copley (see cover). When Copley painted this portrait of Joseph Warren in about 1765, Warren was a respected physician in Boston and just beginning to participate in the movement that would lead to the American Revolution. He had graduated from Harvard in 1759 and apprenticed in Boston with the London-trained Dr. James Lloyd. In 1763, when a smallpox epidemic struck Boston, Warren successfully inoculated

scores of patients with a mild form of the disease and thus prevented their becoming more severely ill. John Adams, one of those whom Warren inoculated, described the doctor as "a pretty, tall, Genteel, fair faced young Gentleman," qualities still apparent in Copley's portrait. Warren's reputation as a successful physician grew, and by the mid-1760s his was the largest medical practice in Boston. This portrait celebrates Dr. Warren's life.

Another option would be John Trumbull's depiction of the death of Dr. Joseph Warren at the Battle of Bunker Hill.



Trumbull, who was in Boston with the Continental Army in 1775, was said to have observed the battle. He immortalized the events in dramatic fashion, elevating them with a heroic iconography that recalls religious art and eschews many facts of the battle in favor of contemporary artistic preferences for nobility and spectacle. This portrait celebrates Dr. Warren's sacrificial death.

Both portraits are the property of the Museum of Fine Arts in Boston. Copies are available there.

#### Where?

- 1. Space has been offered for a statuary-style Dr. Joseph Warren Memorial Monument in the lawn outside of the Lebanon Public Library and Harmon Museum, between the buildings and the sidewalk adjacent to South Broadway St. This site would promise high visibility from both the sidewalk and South Broadway St., as well as enough visibility from the Main St. sidewalks and traffic to lure curious passers.
- Space within the Warren County Administration Building lobby would provide high visibility for an indoor portrait-style Dr. Joseph Warren Memorial Monument.

#### When?

June 17, 2025 marks the 250<sup>th</sup> anniversary of Dr. Joseph Warren's death at the Battle of Bunker Hill on June 17, 1775. This date provides enough time to plan, fund and fabricate these Dr. Joseph Warren Memorial Monuments, as well as a perfect historically significant anniversary on which to dedicate the memorials and celebrate Dr. Warren's story.

#### How?

The realization of these noble goals will require planning, funding and implementation. The Friends of the 20-Mile House, with the support of Michael Coyan & the Warren County Historical Society and Linda Eckert & the Warren County Genealogical Society, has already embraced these common goals. Contained within the group's membership exists those with significant experience and success in planning, funding and placement of other historical markers throughout Warren County. To date more than \$14,700.00 has been pledged toward the Dr. Joseph Warren Memorial effort, most of which is held on deposit at the Warren County Foundation in a fund ear-marked for the Dr. Joseph Warren Memorials.

Our hope also is that the Warren County Commissioners will find their eyes opened to the reality that Dr. Joseph Warren's story is a relative secret within a

county that wears his name. We come to the Warren County Commissioners in search of two things:

- 1. We long to have our private sector funding matched by Warren County Government financial support.
- 2. We are eager to hear fresh perspective and new ideas through the experienced voices of the Warren County Commissioners. Surely together we can determine ways in which we will broaden the base of support for this effort throughout the different townships of Warren County.
