The Project consists of the construction of approximately 350 feet of 12-inch Class 52 ductile iron water main, 185 feet to be jack and bore, and approximately 60 feet of 8-inch Class 52 ductile iron water main bypassing failing existing water main.

 into a contract with the Owner, the contractor must file a performance bond for
 the amount of the contract, and the bid guaranty will then be returned to the
 successful and unsuccessful bidders upon contract execution.

- 2. A form of bid guaranty bond (attached) for the full amount of the bid. Such bond is retained for the successful bidder, but returned to unsuccessful bidders after the contract is executed.
