The County is looking to move away from our legacy analog phone system and into next generation VOIP or other next gen system shortly, and wishes to put together a long range plan of implementation. This would encompass

- An cataloging and analysis of our existing infrastructure and current use
- Developing the process needed to move forward with new technology that best fits the County's needs.
- A financial analysis of our current configuration

We wish to receive an unbiased, skilled, and fully vetted proposal. We feel it would be beneficial to hire an outside consultant

We are in the process of construction a new office building on our main campus. This would be the first project for a next-gen phone system. Occupancy is projected for fall of 2014.

The county is interested in contracting with a consultant that has:

- Expert knowledge of next generation / VOIP systems
- Multi-site telephony architecture and connectivity
- Expert knowledge of dial tone generation and provision of externally supplies resources
