Bid packets may be obtained from the Warren County Water and Sewer Department, 406 Justice Drive, Lebanon, Ohio 45036, for a \$50.00 per set, non-refundable fee. A Non-mandatory pre-bid meeting to answer any questions bidders may have will be held at 9:00 a.m. May 25, 2016 at Warren County Water & Sewer Department, 406 Justice Drive, Lebanon, Ohio 45036. The project description: Renovation and/or replacement of three (3) sanitary lift stations, installation of 7,180 feet of forcemain ranging in size from 4-12 inch, and 1,160 feet of 8-inch gravity sewer. The Engineer's opinion of probable construction cost is \$1,312,000.00.

A Bid guaranty, as required by Ohio Revised Code, Section 153.54, shall accompany each proposal submitted, as follows:

- 1. A Certified check, cashiers check, or letter of credit equal to ten (10) percent of the bid. A letter of credit may only be revocable by the Owner. Upon entering into a contract with the Owner, the contractor must file a performance bond for the amount of the contract, and the bid guaranty will then be returned to the successful and unsuccessful bidders upon contract execution.
  - OR
- 2. A form of bid guaranty bond (attached) for the full amount of the bid. Such bond is retained for the successful bidder, but returned to unsuccessful bidders after the contract is executed.

Attention of bidders is called to all of the requirements contained in the bid packet. No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof. All bids shall be properly signed by an authorized representative of the bidder. All bids shall be sealed and plainly marked:
