ADDENDUM #1

Landen Sewer Lining Project

This Addendum No. 1 is issued to make certain revisions, additions, and clarifications to the original Contract Documents and shall be incorporated into the original Specifications. This Addendum takes precedence over any and all information previously issued. No other revisions to the Specifications are to be inferred.

BID OPENING DATE

1. Bid Opening Date has been moved to March 6, 2018 at 9:20 AM

CLARIFICATIONS

- 2. Bid Item #7 Lateral Connection Lining will use the following specification.
 - a. Lateral lining is intended to create a watertight interface connection seal with the main line sewer.
 - b. Lateral lining should be a one-piece resin impregnated, flexible, non-woven felt liner.
 - c. Liner and resin shall meet the requirements of ASTM F1216, F1743, and D5813.
 - d. The liner shall be a joint-less polyester felt "tube" with a sewn or a semi-rigid collar at the connection which includes a 15-inch full wrap that will create a watertight seal at the main pipe interface.
 - e. The liner shall extend a minimum of 3' up the lateral.
 - f. No cured-in-place reconstruction will be allowed that requires bonding to the existing pipe for any part of its structural strength. Only resin saturation using vacuum impregnation will be allowed.
 - g. The CIPP lateral shall conform to the following minimum standards:
 - i. Flexural Stress ASTM D790 4500 psi
 - ii. Flexural Modulus ASTM D790 250,000 psi
 - h. Cleaning of lateral shall be done from main line.
 - i. Bypass pumping is the responsibility of Contractor.
 - j. Coordination with homeowner is responsibility of Contractor.
 - k. Approved Products: BLD "Service Connection Seal + Lateral" or approved equal.
- 3. Bid Item # 4 Sewer Cleaning Including Lateral Connections to be Lined, cleaning of laterals is only to include lengths to be lined.
- 4. There is no charge for water usage on site, however proper precautions shall be taken as referenced in specifications.
- 5. Debris may be transported by contractor to Lower little Miami Wastewater Treatment Plant at no charge.

Separate sealed bids for the Landen Sewer Lining Project will be received by the Warren County Board of Commissioners at the Office of the Warren County Commissioners, 406 Justice Drive, Lebanon, Ohio 45036, until February 27, 2018 @ 9:20 a.m. and then at said time publicly opened and read aloud.

Bid packets may be obtained from the Warren County Water and Sewer Department, 406 Justice Drive, Lebanon, Ohio 45036, for a \$25.00 per set, non-refundable fee. Questions regarding the technical specifications should be directed to Chris Wojnicz at the Warren County Water and Sewer Department, (513) 695-1646.

The project description: Cured-in-Place pipe rehabilitation of two (2) segments of 10-inch diameter sanitary sewer main, approximately 550 feet, and cured-in-place rehabilitation for five (5) segments of 8-inch diameter sanitary sewer main, approximately 950 feet. The Engineer's opinion of probable construction cost is \$173,000.00.

A Bid guaranty, as required by Ohio Revised Code, Section 153.54, shall accompany each proposal submitted, as follows:

- A Certified check, cashiers check, or letter of credit equal to ten (10) percent of the bid. A letter of credit may only be revocable by the Owner. Upon entering into a contract with the Owner, the contractor must file a performance bond for the amount of the contract, and the bid guaranty will then be returned to the successful and unsuccessful bidders upon contract execution.

- 2. A form of bid guaranty bond (attached) for the full amount of the bid. Such bond is retained for the successful bidder, but returned to unsuccessful bidders after the contract is executed.
