JJC" shall be received at the main desk of the Warren County Commissioner's Office, 406 Justice Drive, Lebanon, Ohio 45036, UNTIL 1:00 P.M. LOCAL TIME TUESDAY, MARCH 26, 2019, furnishing all materials, equipment and labor necessary to perform all work in accordance with the drawings and as set forth in the specifications prepared by Elevar Design Group, 555 Carr Street, Cincinnati, Ohio 45203. Bids shall be publicly opened and read aloud immediately after closing time for said bids.

Proposals must be made on blank forms, placed in sealed envelopes and plainly marked on the outside with the project to which they apply. Each proposal must contain the name of every person interested herein and be accompanied by a guaranty of some disinterested person or a bid guaranty bond in a sum equal to one hundred percent (100%), or alternative forms, as provided in Section 153.54 Ohio Revised Code, of the amount of the proposal, that if same is accepted a contract will be promptly entered into and the performance of same properly secured. Successful bidder/s shall be required to furnish bonds in the amount of one hundred percent (100%) of the contract/s for both performance and payment for labor and materials.
