<p>Reports:</p>	<p>DISCUSSION/CONCLUSION: <u>LEPC Coordinator Update:</u></p> <ul style="list-style-type: none"> • Eplan • LEPC held an exercise meeting on December 2 to discuss the FSE for the spring 2020. March 19 from 0800-1300 at the McClure Fields in Lebanon. It will be a full scale exercise based on the real worlds incident from a tanker that flipped on I75 that was transferred to the McClure fields location to be off-loaded. The scenario will be relatively the same with a catastrophic hose failure that results in a release of the agent. GC Hazmat would like to use a live agent release. <p>Chief Hannigan motioned to inform the LEPC Exercise committee that the LEPC is not in favor of a live agent release for the March 19, 2020 Full Scale Exercise. The LEPC would be willing to partner with GC Hazmat on a training of a live agent release in a controlled environment as part of the exercise education. Sheriff Sims seconded. Motion passed.</p> <p>Next exercise planning meeting will occur on January 28, 2020 1:30 – 3:30 in the EMA training room.</p> <p>David wood reported that the pipeline coalition would like LEPC members to know the dates of the upcoming Paradigm meetings. will send out the dates to all LEPC members. The Pipeline Coalition is recommending members attend.

EMA Update: Lesli Holt reported that the following hazardous materials incidents that were reported to Warren County EMA between September 2019 – December (current date):

- 9/26 – CO Poisoning – 4 patients @ Mason Processing
- 10/3 – Homeowner spilled flammable liquid in garage
- 10/20 – Semi-tanker rollover with explosion and possible entrapment (6,000 gallons diesel spilled)
- 10/22 – tank leaking – small fuel spill
- 10/30 – diesel spill on roadway
- 11/6 – fuel oil tank ruptured in basement of home – 120 gallons leaked, did not enter storm drain system
- 11/19 – Hartz Mountain Company called to report a diesel spill on their property due to a motor vehicle accident. 70 gallons spilled.
- 11/27 – fuel spilled in parking lot of UDF
- 12/1 – Liquid Nitrogen Spill
- 12/2 – Blue substance in creek in Deerfield Twp. (determined colorant for algaecide from local nursery)
- 12/17 – fuel tanker spill – approx. 160 gallons spilled into ditch next to I71 NB from Kings Mills

There were also

- 25 reports of “Odor of Gas” inside and 15 reports of odor of gas outside between September 21 – December 18, 2019
- 8 gas line strikes during that timeframe

Lesli also reported on Warren County EMA’s activities:

- **Exercises:** Warren County EMA evaluated 3 exercises (Springboro Schools Full Scale evacuation, Regional Public Health pandemic flu tabletop, Butler County LEPC tabletop, West Chester Twp tabletop. EMA also participated in the National Weather Service full scale exercise and facilitated portions of the regional pandemic flu exercise.
- **Plans:** Warren County EMA is actively working on updating the county’s Hazard Mitigation Plan. EMA held the first of three meetings on November 22. This meeting focused on identifying hazards to the county, relaying the history and probability of those hazards to stakeholders, and having attendees rank hazards to determine the greatest threats to the county

overall.

- **Public Outreach:** performed three school safety assessments, participated in WC Benefits fair asking preparedness questions to county employees, performed safety assessment of renovated juvenile detention center
- **Response:** to Montgomery County to assist with Family Assistance Center after Dayton Shooting
- **Training:** EMA staff taught CPR to county employees, planned third regional safety summit with neighboring county EMAs.

Upcoming events:

- Second Hazard Mitigation Plan meeting – January 23, 2020. This meeting will discuss possible mitigation projects to lessen risk or effects of hazards.

SERC: Sam Reed reported WC hazardous materials response plan was reviewed and voted on for concurrence at the SERC meeting (which means the plan is good through October 17, 2020).

Grant apps due to Jeff Beattie by February 1, 2020.

Ohio EMA – updated version to CAMEO on December 12th for those who need to update it. There was discussion at the SERC for the RMP (Risk Management Plans) and it is still in the holding pattern at the moment. There are approx 420 RMP facilities across the state who would have additional exercise requirements if this goes through.

Question was posed – does all information that is loaded into the Eplan system get loaded into CAMEO? David Wood reported that all info from Eplan is loaded into CAMEO and GC hazmat does have access to this system.

Ohio EPA: No report at this meeting.

Greater Cincinnati Hazmat:
