



# **Warren County Armco Park Fish Re-stocking Plan**

Lake stocking is a delicate balance between preserving the native ecological systems and introducing sporting fish. The information that you provide can help the park district maintain this balance. Often, sporting fish and native fish are one and the same.

Since our lake is a man-made impoundment true native stream fish would not occur in this valley as this creek ran intermittently prior to impoundment. However, the selection of sporting fish and other fish types to manage the lake quality must be carefully considered. The introduction of grass carp many years ago proved to be a detrimental addition to the lake as they devoured habitat needed for nesting and fry maturation of other species of fish. The grass carp have now matured to sizes and ages that they no longer aggressively feed on habitat, so we can expect a return to natural nesting sites, particularly if we actively manage their removal or containment.

So, with the understanding that the fish re-stocking plan and the lake quality management plan go hand-in-hand, please take a moment to answer a few questions to assist us in planning and prioritizing our lake management. When answering questions circle all that apply, you may have more than one answer for each question.
